- 2. These TBRSUs vest 40% on the third trading day following the annual earnings release date for the fiscal year ending December 31, 2013; 30% on the third trading day following each annual earnings release date for the fiscal years ending December 31, 2014 and 2015. Each tranche is settled within 10 business days after vesting.
- 3. These options were granted on August 23, 2004 and are fully exercisable.
- 4. These options were granted on December 3, 2004 and are fully exercisable.
- 5. These options were granted on December 9, 2005 and are fully exercisable.
